2. **GENERAL INSTRUCTIONS**

The price shall be filled in Col. 5 and delivery date in Col. 6 of the schedule to the Tender Enquiry. The undertaking shall be signed at the bottom of the schedule.

6.0 FAILURE TO SUPPLY THE STORES:

All the deliveries must be completed by the specified date.
