If a representative is deputed, he should bring a **letter of authority**. The venue of Tender Opening is **POFs Bid Centre (Room No. 02), Behind Rabta Hall, POF, Wah Cantt.**

1. SUBMISSION OF TENDER

1.1 Please quote as per following single stage two envelope method. You are required to quote in two parts: -

- a) **Part I "Technical Offer":** It should exclusively give technical details and literatures/brochures of the offered store; validity date; delivery schedule; and signed undertaking given on the schedule to this Tender Enquiry. **Bid Money of Rs 5,000,000/- should accompany in the shape of Pay Order with Technical offer. Tenders received without Bid Money will be rejected.**

Note: it must not indicate price, costs etc.

- b) **Part II "Commercial Offer":** It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply. Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: Part I "Technical Quotation without Price" and Part II "Commercial Quotation with Price".

1.2 Only one tender should be included in one envelope. The outside of the envelope should be inscribed with: -

2.0 **GENERAL INSTRUCTIONS:**

- 2.1 The quotation must remain valid for at least **15 working days** from the date of opening of tenders.
- 2.2 The quotation should hold good for any reduced or enhanced quantity without notice.
- 2.3 Conditional offers or alternative offers are likely to be ignored.
- 2.4 Quotations should be based on "Free Delivery" at Wah Brass Mill Quaid Avenue, (Adjacent to POF Main Gate), Wah Cantt.
- 2.5 The suppliers registered with Sales Tax Dept. are eligible to participate in the T.E. The competitive supplier shall have to furnish Sales Tax Invoice and Professional Tax Clearance Certificate.

3.0 **TENDER FEE:**

- 5.1 The successful bidder will provide Performance Guarantee at the rate of 5% of the contract value in favour of CEO / MD Wah Industries Limited, Wah Cantt. The Performance Guarantee will be furnished in the form of Pay Order from any scheduled bank. The Performance Guarantee will be submitted prior to the placement of Contract and the same will be returned on satisfactory completion of the contract. In case the firm fails to supply the contracted store / contractual obligations, PG will be forfeited.

7.0 **ACCEPTANCE OF OFFERS:**

7.1 The Right to accept or reject any offer in full or in part, without assigning any reason is hereby reserved.

8.0 **FAILURE TO SUPPLY THE STORES:**

8.1 Performance Guarantee @ 5% of the total value of contract will be submitted prior to the placement of contract. The Performance Guarantee will be returned on satisfactory completion of the contract. In case of failure of the supply, the Performance Guarantee will be forfeited. All the deliveries must be completed by the specified date. If the failure to deliver the stores within the scheduled time should have arisen from "Force Majeure", which the purchaser may admit as reasonable ground for further time, he will allow such additional time as he may consider to have been required by the circumstances of the case. Otherwise, he will be entitled, at his discretion, to cancel the contract; and / or, claim liquidated damages up to 2% but not less than 1% of the contract price of the items and their quantities for each and every month or part of a month, beyond the specified delivery date, during which these may Not be delivered, subject to a maximum of 10% of the total contract value; or, to purchase from elsewhere, the unsupplied stores at the risk and cost of the supplier.

9.0 **MATERIAL / STORES:**

9.1 The material / stores shall conform to the specifications as laid down in the schedule to Tender Enquiry.

10.0 **SAMPLE:**

10.1 The bidder firm should invariably furnish the sample along with the offer. Technical Offers without sample are liable to be rejected.

11.0 **WARRANTY / GUARANTEE:**

11.1 The stores shall be supplied on Warranty / Guarantee subject to Inspection at WBM. Rejected stores will be removed and replaced with the acceptable store by the supplier at his own expenses within specified time.
