Tender will be opened at 1030 hours on 27-8-2025 (Wednesday) and must reach POF Bids Centre through Air mail / courier before 1000 hrs. The tender received late will not be entertained. The bids "By hand" must be received in the Bid center 30 minutes before the time of Bid opening. You may witness the opening of the tender if so desired. If a representative is deputed, he should bring a letter of authority. The venue of Tender Opening is POFs Bid Centre (Room No. 02), Behind Rabta Hall, POF, Wah Cantt.

1. SUBMISSION OF TENDER

1.1 Please quote as per following single stage two envelope method. You are required to quote in two parts: -

A. Part I "Technical Offer":

- i. It should exclusively give technical details and literatures/brochures of the offered items; validity date; delivery schedule; and signed undertaking given on the schedule to this Tender Enquiry. It must not indicate price, costs etc. Bid Money of Rs. 120,000/-should accompany in the shape of Pay Order with Technical offer. Tenders received without Bid Money will be rejected.
- ii. In case the offer is submitted thorough a Local agent / firm is involved in the submission of bid. Local agent / firm must invariably be accompanied by tender fee @ Rs. 2500/- and bid money amount to Rs. 120,000/- in shape of pay order. Failing which offer will be rejected.

Note: it must not indicate price, costs etc.

- **B.** Part II "Commercial Offer": It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply. Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: Part I "Technical Quotation without Price" and Part II "Commercial Quotation with Price".
- 1.2 Only one tender should be included in one envelope. The outside of the envelope should be inscribed with: -

2.0 GENERAL INSTRUCTIONS:

- 2.1 The quotation must remain valid for at least 90 days from the date of opening of tenders.
- 2.2 The quotation should hold good for any reduced or enhanced quantity without notice.
- 2.3 Conditional offers or alternative offers are likely to be ignored.
- 2.4 Quotations should be based on "Free Delivery" at Wah Brass Mill Quaid Avenue, (Adjacent to POF Main Gate), Wah Cantt.
- 2.5 The suppliers registered with Sales Tax Dept. are only eligible to participate in the T.E. The competitive supplier shall have to furnish Sales Tax Invoice and Professional Tax Clearance Certificate.

3.0 TENDER FEE:

The Tender must be accompanied by a non-refundable fee of rupees **Rs. 2,500/-** by means of a **Pay Order** in favour of CEO / MD Wah Industries Ltd., Quaid Avenue, Wah Cantt. The Tender fee must be made part of Technical offer.

4.0 BID MONEY:

- 4.1 Bid Money amounting to **Rs. 120,000/-** should accompany in the shape of **Pay Order** issued from a Scheduled Bank drawn in favour of CEO / MD Wah Industries Ltd. **Tenders received without Bid Money will be rejected. Bid money must be made** part of technical offer.
- 4.2 Bid Money of the unsuccessful bidder will be returned as soon as the scrutiny of the tenders is completed. Bid Money of the successful tenderers will be retained until the contract is finalized. Bid Money will be forfeited in case the quotation is withdrawn before the expiry of its validity date.

5.0 PERFORMANCE GUARANTEE:

5.1 The successful bidder will provide Performance Guarantee at the rate of 10% of the contract value in favour of CEO / MD Wah Industries Ltd, Wah Cantt. The Performance Guarantee will be furnished in the form of Pay Order from any scheduled bank. The Performance Guarantee will be submitted prior to the placement of Contract and the same will be returned on satisfactory completion of the contract. In case the firm fails to supply the contracted store / contractual obligations, PG will be forfeited.
